## **OFFICE MEMORANDUM**

Subject: Recognition/Re-verification of Association of AIR and Doordarshan under CCS (Recognition of Service Association) Rules, 1993-reg.

Reference this Directorate O.M. No. 503/1/2016-Scor-II(Pt) dated 02.05.2017 on the above Subject.

- 2. As the re-verification process under the said Rules has not yet been carried out in respect of 10 Associations of Prasar Bharati/ DG: DD after recognition in the year 2013 and the recognition of these Associations has been kept in abeyance till the process of re-verification of membership is complete vide this Directorate's Office Memorandum of even no., dated 02.05.2017. Accordingly, all the Heads of Office/ DDOs of DG: DD were directed not to deduct annual subscription from any member of such Associations till further orders.
- 3. The Ministry of I&B vide letter No. V-22026/09/2017-BA(E), dated 28.08.2017 requested to initiate the process of re-verification of membership of all Associations recognized vide their dated 06.03.2013. The Ministry also requested that fresh applications Seeking recognition may also be called for and the whole exercise in terms of Central Civil Services (Recognition of Service Association) Rules, 1993 and DoPT's instructions contained in OM dated 10.02.2002 be completed.
- 4. It is pertinent to mention here that Central Civil Services (Recognition of Service Association) Rules, 1993 stipulates deduction of annual subscriptions from the salary of employees who choose to be member of any of the applicant Associations for both the modes viz. for re-verification process as well as fresh recognition process.
- 5. At present, this Directorate is in receipt of requests from 13 applications from Associations, out of which 10 are the erstwhile recognised Associations and 3 are fresh applicants seeking recognition. A List is enclosed.

6. It has now been decided that the HOO/DDO concerned may initiate the deduction of membership fee/annual subscription as the case may be, from employees who wish to affiliate themselves to any of the applicant service Associations. They may ensure that the requisite letter authorization from the desirous employees for subscription may invariably be obtained and send a consolidated list category wise alongwith a copy of authorization to this Directorate latest by 31st March, 2019 for further necessary action.
