Sir,

Most Respectfully it is draw your kind attention that on the basis of DG (AIR) Letter No. 14/07/2015-S IV(A) dated 18.03.2015, orders were issued by Zonal Offices to refix and recover the third MACP granted to Senior Technicians.

Against this order, ARTEE filed the OA No. 3035 of 2015 in Hon'ble CAT-Delhi and in its hearing dated 14.08.2015 ,Hon'ble CAT Delhi stayed the Recovery and allowed refixation and hence all the Sr. Technicians were downgraded from 4800 GP to 4600/-.

On 08.08.2018 Hon'ble CAT allowed the OA in favour of applicants with all consequential benefits in terms of full bench decision of Delhi CAT in OA No. 1288/2014 dated 20.03.2016. However the same was subjected to the result of SLP filed before Hon'ble Apex Court vide Diary number 28485/2017.

It may be noted that this Association had filed Contempt Petition No. 394 /2019 in respect of the OA No.3035 /2015 in Delhi CAT and in response to it, DG AIR had filed a status report on 03.02.2020 on behalf of respondents. (Copy attached as Annexure I) .As per the status report it was informed by the DG AIR on behalf of respondents that they would implement the directions of Hon'ble Delhi CAT order, if the Hon'ble Apex Court upheld the orders passed by the lower court in the similar case.

Now we are very happy to inform you that on 17.08.2021, Hon'ble Apex Court dismissed the SLP filed before Hon'ble Apex Court vide Diary number 28485/2017. (Copy of the order attached as Annexure II). Hence the order of the Hon'ble CAT-Delhi becomes final.

Hence it is earnestly requested to implement the directions of the Hon'ble Delhi CAT in OA No.3035 / 2015 and grant the 3rd MACP to Sr. Technicians working in All India Radio and Doordarshan.
