Respected Sir,

I have been working as Engineering Helper in subordinate engineering cadre of AIR & DD since As you are kindly aware, the promotion channel in subordinate engineering cadre has been blocked due to various reasons in our department and Helpers like me who are in the feeder cadre of Technicians are the victims of this inordinate delay in the promotions in AIR & Doordarshan.

Due to staff shortage , transfers etc, I have been assigned to perform the duties and responsibilities of Technician for a very long time. This has given me considerable on-job experience.

But due to lack of promotion channel vacancies Technician cadre, Helpers like me in AIR and DD are stagnating for last many decades. This is because, every year the number of promotion quota Technician vacancies is only in single digits. Hence, even though many Helpers are qualifying in the LDCE, only a few are getting promotion.

Sir, it is learnt that a number of vacancies are available in technician cadre. I humbly request your kind intervention in solving acute stagnation among helper cadre by diverting direct recruitment quota Technician posts to promotion quota through department competitive examination.

I submit that besides solving the acute stagnation among Helpers, this move would enable the department to solve the staff shortage problem in Technician cadre and utilize the experience, competence and on-thejob knowledge of Helpers effectively.

It is learnt that a similar exercise to solve the shortage among Programme Executive cadre happened in 2013. Ministry of Information & Broadcasting in consultation with DoPT and UPSC accepted the proposal of DG-AIR for diversion of 174 vacant posts of Direct Recruit quota Program Executive to promotion quota, to enable Transmission Executives to fill these posts on promotion. This enabled not only to fill up the most vital post of programme cadre, but also solve the stagnation among Transmission executives. (Copy of the approval of Ministry of Information & Broadcasting in attached with this representation).

It is also learnt that, in the 1980's, through exemption, a few Diploma qualified EAs were promoted as first AEs then ASEs, even though at that time even AE post was reserved for only Degree qualified persons.

A similar favorable action may kindly be extended in our case also.

Hence I once again request your kind intervention to find a solution to the acute stagnation in the most neglected and low-paid Helper cadre by diverting sufficient number of direct recruitment quota Technician posts to promotion quota by taking one time exemption from DoPT for relaxation in Technician recruitment rules.
