Respected Sir,

With most affectionate regards, we would like to remind your high office about widespread resentment against an arbitrary decision of DG Doordarshan to treat EA/SEA promotions as One Upgradation while granting MACP and therefore violating the DoEXP Order dated 13/11/2009 & MACP guidelines issued time to time by DoPT resulting in huge monetary loss to retiring Employees in settlement of their superannuation benefits. The **copy of DG DD Order 20/4/2021S.IV/765 dated 05.3.21** issued in case of an Individual Late Ravi Kant Verma, Retired SEA, DDK Jammu is enclosed herewith as **Annexure I** for your kind perusal. There are possibilities of several cases of retiring subordinate engineering employees alike that across the country in our department. The wrong interpretation of MACP rules by DG:DD is causing huge monetary loss and delay in the payment of terminal benefits to the retiring employees This is also a clear violation of Article 14, 16 and 21 of law of the land.

This Association wrote a letter ARTEE/P/02/2020-21/53 dated 12/3/21 (copy enclosed as **Annexure II**) explaining all the facts and requested your good self to review this decision after giving careful considerations to the facts highlighted in our above mentioned representation so that retiring Sub-

Ordinate Engineering staff may get the timely payment of dues on superannuation without re-fixation and reduction.

We express our disappointment that no action has been taken on the letter even after the lapse of almost four weeks. Sir in the light of facts mentioned in our letter, we want to politely remind to review the matter.

An urgent intervention from your high office is requested.
