The first Meeting of ARTEE Central Council for CWC 2022-24 was held online today, i.e. 08 July 2022.

The following issues were discussed and resolutions taken:

- First of all, the CC meeting placed on record its appreciation of the service done by outgoing CWC 2020-22 to the members. On the request of CC members, outgoing President Sh.
 Yogesh Kumar was invited to join & address the meeting. He spoke about the Provisional pension matter and the latest meeting of PAOs in which it was decided to review the Service Reocrds of all the staff who are going to retire in next 5 years.
- The President informed the CC that after the positive CAT verdict in provisional pension OA 2691/2021, a Caveat has been filed in Hon. Delhi High Court against any adverse move from department like challenging the CAT verdict.
- About the two DGAIR clarifications dated 30 June 2022: On the clarification on Tech MACP, it was welcomed and resolved to inform members to apply for release of MACP quoting this clarification. On the clarification counting SEA promotion against one MACP, it was resolved to immediately approach the advocate in EA-SEA merger case for further action.
- On the various audit objections in different stations all over the country, it was resolved that, based upon the nature of each audit observation, first an attempt must be made to

resolve the issue at local level. If the local administration seeks clarification from zonal or DG level, then zonal / national leadership should immediately take up the issue with those authorities.

- It was resolved to work closely with Kerala team on Thrissur audit objection case. It was also resolved that Association will authorise State Secretary to become party in the case alongside effected applicants. CC was also informed about the decision taken in first CE meeting regarding central funding of the case.
- It was resolved to immediately seek nominations for vacant posts.
- On proposals from members to work jointly with any sister association, it was felt that issuebased joint working could be considered. If the sister association comes forward with a concrete proposal on any issue, then a joint forum to resolve that issue could be considered.
- It was agreed by the CC that the most important step towards resolving the 25.02.99 issue is treating the 5000 scale of Technician and 6500 scale of EA as normal replacement scale. It was resolved to make efforts in this direction.
- It was resolved to make both organizational efforts as well as legal efforts to solve the pending issues.
