

## Minutes of Online Central Council Meeting Held on 02.06.2022

An online Central Council meeting has been called 02.06.2022 at 08.00 pm with a single agenda of ARTEE elections in the background of non implementation of unanimous decision of Central Council by Treasure and General Secretary to release funds to R.O to conduct election. President welcomed all members to the meeting and informed the House that both Treasure and General Secretary are not willing to implement the unanimous decision of the Central Council meeting dated 30.05.22, to release necessary funds to Returning Officer to Conduct Elections. (Central Council meeting held on 03.06.22 had unanimously decided to Central Council unanimously decided to immediately release fund to R.O for conducting election after his written request for the same, as the ongoing election process should not interrupted due to shortage of fund). The House took a serious view of the fact that both General Secretary and Treasurer not respecting and implementing the unanimous decisions taken by the Central Council. The House also took a serious view about the fact that General Secretary and Treasure are not attending important Central Council meetings and openly questioning decisions of Central Council in social media platforms. Earlier in the CC meeting held on 31.05.22 also, the House had expressed its concern and displeasure about the continuous absence of General Secretary and Treasurer in the important Central Council meetings. The House observed that General Secretary was absent in the Central Council meetings held on the following dates.

- 2) 06.04.22
- 3) 30.05.22
- 4) 05.05.22
- 5) 03.05.22.

The House observed that Treasure was absent in the Central Council meetings held on the following dates

- 2) 06.04.22
- 3) 05.05.22
- 4) 03.05.22

In the only meeting in the recent past which was attended by both Treasure and General Secretary, (held on 21.05.22), both General Secretary had assured the Central Council to release the required fund to R.O if the central council decides to release fund to R.O . And in the meeting of Central Council held on 30.05.22 which was attended by Treasure also, it was unanimously decided to immediately release fund to R.O for conducting election after his written request for the same, as the ongoing election process should not interrupted due to shortage of fund. But even after that both Treasure and General Secretary are not releasing the funds to conduct elections with the intention of preventing the formation of next CWC. The House unanimously condemns the actions of General Secretary and Treasurer and observed that both General Secretary and Treasure are crossing all limits of discipline and hence acting against the unity and integrity of the Association by doing serious anti Association activities. The House opined that suitable action must be taken by the next CWC in this subject.

All the Central Council members attended the meeting are of the view that the election process must be completed as per the time schedule already published by the R.O. Since the Treasure and General Secretary are trying to stop the election process by denying funds to R.O to conduct election, the Central Council unanimously decided to complete the election process by taking contribution/ donation from zones to give funds to R.O to conduct the Election. The Meeting ended with the vote of thanks by the chairman of the meeting Sri. Yogesh Kumar.
