A Meeting of ARTEE Central Council was held online on 04 Feb '23. The following CC members attended the meeting:

Following issues were discussed and resolutions passed:

1) Organizational: filling up vacancies caused by promotion of three Central Executive members:

As per Clause 56 i) & ii) the President has proposed following names to Central Council:

Addl GS : The President has proposed to nominate Sh. G. M. Tyagi, Tech,

Broadcasting House for this post

Sec AE : The President has proposed to nominate Sh. Anil Singh, AE, Prasar Bharati

for this post

Treasurer: Sh. D.K. Sangal (Secretary (SEA/EA)) has expressed willingness to resign his

present post and work as Treasurer if nominated. Further details will be

worked out.

- 2) Service matters:
 - Declaring Technicians 5000-8000 scale as normal replacement scale from Ministry. It was resolved to persuade and convince the authorities both at DG-AIR / PB end as well as in Ministry for speedy implementation.
 - Latest case WPC 1272/2023 filed by govt in Sr Tech MACP issue, promotions etc: It was explained by President that, on 08/08/2018 the Ld. CAT disposed the OA 3035/2015 filed by ARTEE in terms of its earlier judgment in Manju Vashista case which granted 3rd MACP to the applicants 20 years after promotion. However, it was subject to the outcome of the SLP filed by govt in Manju case. On 07.08.2021, tThe Hon. SC upheld the CAT judgment and the latter Hon. HC judgment in Manju case. However, the Hon. Judges kept the questions of law open. Utilizing this opportunity, department filed WPC 1272/2023 in Hon. Delhi HC. Immediately ARTEE filed a caveat. On 01 Feb 2023, Hon. HC set aside the order dated August 08. 2018 passed in O.A. 3035/2015 and revived the O.A. 3035/2015 on the board of the Tribunal for a fresh consideration, in accordance with law.
