**Subject:- The extension of current CWC Term 2022-24-regarding**

Sir,

This is with reference to the letter No. ARTEE/AR/2024/01 dated 24.03.2024 (copy enclosed) vide which your office was informed about the about the extension of the term of current CWC by three months as per resolution adopted in Central Council meeting held on 15.03.2024 in the backdrop of ongoing Civil Suit No. CS SCJ 1099/2022 filed by Sh. Vijar Haror.

Further, it was informed that incumbent President has been promoted as ADE but the M/o of I & B's order dated 14.12.2023 granting one time relaxation in Recruitment Rules has been set aside by the CAT, Delhi vide order dated 19.03.2024. It is further informed that the promotion order of the incumbent President could not be withdrawn due to stay granted by the Hon'ble High Court of Delhi vide interim order dated 08.05.2024 and 24.05.2024 in WP No. 6549/2024 and the matter of promotion is still sub-judice.

As the order dated 14.12.20023 issued by the Ministry of Information and Broadcasting, GOI, granting One Time Relaxation (OTR) in Recruitment Rules to the existing Diploma holder Assistant Engineers has been set aside by the Hon'ble CAT, Delhi vide order dated 19.03.2024 in OA No.4036/2023 and the matter is still sub-judice in the Hon'ble High Court of Delhi in WP 6549/2024 filed by the incumbent President, it cannot be held that the membership of incumbent President will be discontinued automatically, in terms of Article 5 (d) (ii) of the RSA Rules, 1993, on his ceasing to belong to such distinct category of Government servants having common interest as defined in Article 5 (c) of the RSA Rules, 1993. Thereby, this matter was referred to be decided by the CWC in terms of the authority vested in CWC under Article 29(vii)

of approved Rules and Regulations by the Central Council of the ARTEE in the meeting held on 15.03.2024 in the Conference Hall of DG: Doordarshan, Copernicus Marg, New Delhi-110001.

Though the decision taken on 15.03.2024 by the physical meeting of the Central Council was unanimous and General Secretary was also part of the decision making process, he choose not to publish the minutes of meeting the Central Council and at a last resort President has to publish the same on 06.08.2024 after General Secretary conspired with VP(TV) and AGS(org.) to remove the incumbent President from the post without any authority in the illegal online CC meeting held on 03.08.2024. The General Secretary was prompt in publishing minutes of meeting of online Central Council held on 03.08.2024 the very next day as well as the said online CC meeting illegally modified minutes of meeting of last physical Central Council meeting held on 15.03.2024 (copy enclosed). The proceedings / minutes of the online meeting of Central Council held on 03.08.2024 have been declared as invalid, void and non-est as being violative of the approved Regulations of the Association vide Presidential Note dated 05.08.2024 (copy enclosed).

In view of the above, it is requested that the mail dated 07.08.2024 sent to your office by the General Secretary (copy enclosed) may kindly be treated as null and void as the entire matter is being referred to the highest decision making body of the Association, the CWC which shall be convened shortly. The decision of the CWC shall be conveyed to your office in due course.
