**Subject:- The extension of current CWC Term 2022-24-regarding**

Sir,

This is with reference to the letter No. ARTEE/AR/2024/01 dated 24.03.2024 and 13.08.2024 (copy enclosed) vide which your office was informed about the about the extension of the term of current CWC by three months as per resolution adopted in Central Council meeting held on 15.03.2024 in the backdrop of ongoing Civil Suit No. CS SCJ 1099/2022 filed by Sh. Vijar Haror.

In this regard, it is informed that the said Civil Suit has been withdrawn by the applicant on 19.08.2024. After the withdrawal of Civil Suit, it has been decided to conduct the elections for the next CWC as soon as possible after taking necessary approvals from the General Body of the Association scheduled to be held in Chennai on 11.09.2024.

It is further informed that the notices have been issued to the General Secretary, VP (TV), AGS(Org.) and Asstt. Treasurer (copy enclosed) for their anti-association activities as intimated vide letter dated 13.08.2024.. Meanwhile, self proclaimed President (I/c) Sh. U.K.Shukla, VP(TV) has announced illegitimate election process for the next CWC instead of resolving the dispute in General Body meeting of Association scheduled to be held at Chennai on 11/09/2024 in place of CWC as announced earlier vide Notice dated 14.08.2024.


An urgent meeting of Central Council was held on 02.09.2024 at 1400 hrs in Delhi under the Chairmanship of Vice President (AIR) to discuss the agenda for CWC scheduled to be held in Chennai on 11.09.2024 and deliberate on the current scenario.

Keeping in view the organizational crisis created by the illegitimate activities of the dissident group comprising of GS, VP (TV), AGS (Org.) and Asstt. Treasurer, it was unanimously resolved to convert proposed CWC meeting into the General Body meeting to be held at Chennai on 11.09.2024 under the Chairmanship of Vice President (AIR) as per the schedule announced earlier for CWC meeting in terms of Article 36(viii) of the Rules and Regulations of the Association. The Minutes of meeting of Central Council dated 02.09.2024 and Notice/Corrigendum for General Body meeting are enclosed herewith for your kind reference

The unauthorized elections announced by the dissident group have been declared as null and void. The entire matter is being referred to the highest decision making body, the General Body of Association.

The proceedings/ resolutions passed by the General Body of ARTEE shall be filed with your office for necessary information and action at your end as required under Clause 4 of the Societies Registration Act, 1860.
