This is with reference to the letter of even number dated 05.09.2024 (copy enclosed) vide which your office was informed about the about the conduct of General Body meeting of the association scheduled to be held at Chennai on 11.09.2024.

It was informed earlier that the notices have been issued to the General Secretary, VP (TV), AGS (Org.) and Asstt. U.K.Shukla, VP(TV) has announced illegitimate election process for the next CWC instead of resolving the dispute in General Body meeting of Association held at Chennai on 11/09/2024. The illegitimate election conducted by Sh. U.K.Shukla, VP (TV) under the supervision of illegitimate RO, Sh. Sanjay Singh, have been declared invalid by Resolution no. 14 adopted by the General Body on 11.09.2024.


It was also resolved to conduct the election for the CWC term 2024-26 under the Chairmanship of Sh. Joginder Singh, President (I/c) and appointment of Sh. Lalit Mohan Joshi, Sr. Tech working in the O/o ADG(NZ), New Delhi as Returning Officer(RO) was approved by the General body as per Resolution no. 15. In pursuance to the resolution adopted by General

Body, election process has been set in motion by Sh. Joginder Singh, the President (I/c) by the issuance of notification dated 17.09.2024 (copy enclosed).

The Sh. Lalit Mohan Joshi, RO appointed by the General Body has commenced the election process. The communications issued by the RO are enclosed herewith for your kind reference.

The proceedings/ resolutions passed by the General Body of ARTEE shall be filed physically with your office for necessary information and action at your end as required under Clause 4 of the Societies Registration Act, 1860.
