

Minutes of ARTEE Central Council meeting dated 31 August '22 :-

A Meeting of ARTEE Central Council was held online on 31 August 2022. The following CC members attended the meeting:

Following issues were discussed and resolutions passed:

1). President Sh. Hari Gopal Sharma informed the Meeting that Sh. Vijay Haror, President Contestant in recently concluded ARTEE election, has filed a case against the election. Hearing is in December month. Apart from ARTEE association, Sh. Yogesh Kumar (ex-President), Sh. Richhariya (Returning Officer), Sh. Manoj Gupta (ex-General Secretary), Sh. RB Dwivedi (ex-Treasurer) and, Registrar & Asst Registrar Prayag Raj have been made parties.

On 23/07/2022, the President constituted an Inquiry Committee as per Clause 21 c) of the election byelaws, on the recommendation of RO. No complaint was submitted to that committee.

President and other CC committee members informed the meeting that in spite of repeated attempts by many well-meaning individuals, including the President, to work with Sh. Vijay Haror and utilize his services for the welfare of members, he has never accepted the conciliatory attitude of the newly elected body and repeatedly used abusive language. As Unit Secretary of ARTEE DD New unit, he has written letters to CEO bypassing state, zonal and National committees, which is totally against the spirit of association work.

President told the meeting that we need to defend the court case. He sought permission of the CC to take all necessary action. It is resolved to extend mandate to the President to defend the case in Court of Law on behalf of the association. Meeting condemned the action of Sh. Vijay Haror in going to court instead of trying to resolve the issue by discussion.

Due to the unprecedented situation prevailing at present, it is resolved to invite former Presidents Sh. Umesh Chandra and Sh. Yogesh Kumar, to future CE/CC meetings as Special Invitees.

During the course of the meeting, Sh. Pradeep Kataria used wild and unparliamentary words against President and other office-bearers. Meeting condemned the language used by Sh. Kataria. His language and choice of words indicated that he was not in a sober condition. His behaviour was inappropriate and regrettable. Meeting resolved to not invite him to any further CE / CC meetings and the matter would be immediately referred to CWC. It is also resolved that he would be removed from ARTEE CE/CC/CWC WhatsApp groups until CWC decides on the matter.

In the earlier CC meeting held on 5th August, it was resolved to hold a physical CWC meeting in September month. Now, due to changed circumstances and unprecedented situation, it is resolved to first conduct a physical CC meeting in September month, before holding a physical CWC meeting. Dates of the CC meeting would be decided shortly.

Legal Fund: It is resolved to publish the financial position of the association immediately. It is also resolved to raise a legal fund as early as possible, since for the last three years RSA subscription has not been made. It is proposed to seek Rs.500/- minimum contribution from each member.

Meeting ended with the vote of thanks by the chair.
