SUB: Delay in payment of Salary/ arrears of MACP at various stations

Sir,


I request your kind attention to the discussions I had with your goodself and Member (Finance) in your chamber on 12/8/2010 in which I have brought it to the kind notice that the payment of salary has been delayed at various stations and it became a regular practice at various stations since last some months.

Sh. Raghu Raman, AM has pointed out that some stations have utilized the amount in salary head for paying arrears of MACP to staff members thereby facing the shortage of fund for salary. When the undersigned pointed out that O/O DG:AIR issued instructions to stop the payment of arrears from the account of salary, Member(F) was kind enough to clarify that DA, MACP etc are part of salary and that cannot be separated from the salary account and thereby employees cannot be deprived of the MACP arrears with that excuse especially when Prasar Bharati has already provided necessary amount for payment of arrears of MACP. M (F) has accordingly instructed Asst Manager to put up the file for issuing instructions, not to stop payment of MACP (along with arrears) to the staff members.

I will be grateful to your goodself if you can confirm the same with the status of the issue.






