**Resolutions :**

1. **Transfer policy:** As Transfer policy is part of service conditions and being Government Employees working in Prasar Bharati on deemed deputation, Transfer policy for Central Government employees vide DOPT OM dt. 14.07.1981 should be continued. However Prasar Bharati may issue the guidelines to execute the existing Transfer policy.

Suggestions may be forwarded to Prasar Bharati for smoothing, transparency and solutions of local/practical problem in transfer/posting of employee.

Sh. Gajendra Sharma (VP AIR), Paritosh Kaushik (Treasurer), L. R. Gupta VP(NZ), Anup Katiyar (Sec-Tech/Sr. Tech) will prepare consolidated note for Suggestions and submit the details by 14/10/2013 to president .

- 2 **Communication to Authorities:** House resolved that as far as possible, all communication will be sent with signature of President and General Secretary both In the absence of any one if communication is to be sent the other will be informed by telephonically/SMS. House also that resolved communication between President and Gen.Secy. should be better.

House also resolved that any communication to authorities will be uploaded on ARTEE Web site before any socializing website.

- 4 **On the issue of LA-Tech, EA-5K and Patna ACP:** House resolved to focus, demand and mentioning only implementation of the Apex court verdicts on the issues.

Umesh Chandra President & Sh. Gajendra Sharma, VP (AIR) will visit, Patna to explore all possibilities at a suitable time. VP(AIR) will liaison this with Applicants of PATNA.

All around Efforts are on to generalize the benefit. House also appeal individuals not to approach court of law in batches as it may complicate the issue and Govt may have an excuse in future to delay it as happening in EA(5K) and EA and SEA Merger issues linking the various court cases.
