Further regarding granting Rs. 5400 GP PB II and Rs. 5400 GP PB III as second and third financial upgradations for AEs. We once again convey our thanks for your concern. Meeting of screening committee already convened on 01/09/2010. **Now We request you that work of preparing Eligibility List of remaining AEs and DPC should be carried out at the earliest and positively before commencing Common Wealth Games as it will provide benefit of enhancing the eligibility criteria in the event of extensive touring by the AEs to cover the Games.**

Your are also requested to ask your officers to make their sincere efforts for the job of collecting the Missing CRs if it is not possible to obtain CRs It is requested to follow DOPT guidelines in the event of missing CRs

Further in reference of your letter about AE to JTS promotions. The status told by your office is known to every body and the same status is being conveyed for quite a long time. **We demand that work of granting these promotions should be carried out in a time bound manner.
