Sub: Request not to initiate any activities for the implementation of Prasar Bharati till Hon'ble GoM decides on our demand of Repeal PB Act 1990

Sir,

Kindly refer to the meetings held with Smt. Ambika Soni, Hon'ble Minister for Information & Broadcasting on 15th March and with your goodself on 16th March 2010 and thereafter the letters in reference, issued by the Ministry & your goodself in which it was assured that the proposal from this Federation to Repeal Prasar Bharati Act 1990 will be forwarded to the Hon'ble GoM. Accordingly we have submitted the reasons, justifying our demand for Repealing Prasar Bharati Act 1990, with a request to forward it to the Ministry & Hon'ble GoM.

Hon'ble Minister of State for I&B replied in the Hon'ble Parliament on 26.4.2010 that the demand of NFADE to Repeal Prasar Bharati Act, due to the bad experience for last 12 years, has already been forwarded to GoM

The Federation and the employees have been waiting for the discussion on our demand in the Hon'ble GoM, since the assurance from your office to present our demand in front of Hon'ble GoM. But, unfortunately, instead of presenting our case, your goodself presented a glorified financial picture to Hon'ble GoM.

Meanwhile your good office has issued the letter in reference in which it is stated that your office is planning to recruit employees, with excuse that Hon'ble GoM decided to handover the employees who have joined after 05/10/2007 to Prasar Bharati. We have repeatedly brought it to your kind notice that you can continue the recruitments, like the ones recruited after 5/10/2007, till taking a final decision on our demand of Repeal Prasar Bharati Act 1990.

The general body meeting of this Federation held on 18/5/2010 decided to strongly oppose any activities for implementation of PB Act, till taking a final

decision by Hon'ble GoM on the demand of NFADE, which is already included in the agenda.

We would like to inform your good self that any such steps, including the preparation RR for Prasar Bharati will create an unrest in the entire organization which may compel this Federation to restart the agitation which was deferred on the assurances from the Ministry & your good office.

Under these circumstances we request your good self to kindly advise the Prasar Bharati Secretariat to restrain from any such process to implement the Prasar Bharati and to continue the recruitments and other formalities as per the existing RR of the government, till a final decision on our demand of Repeal Prasar Bharati Act 1990, is made.
