Sub: Merger of Engineering Assistant with Senior Engineering Assistant

Sir,

With due respect we request your kind attention to the Gazette notification dated 29<sup>th</sup> August 2008 through which the Government of India had revised the pay scales and other related benefits of government employees w.e.f.1.1.2006 [CCS(RP)Rules, 2008].

It may kindly be noted that one of the decisions in the above said notification [Part B&C, Section I, sub section (ii)] is to upgrade the pay scale of Rs.6500-10500 to the next higher grade in the pay band PB-2 with Grade Pay of Rs.4600/- corresponding to the pre-revised scale of Rs.7450-11500. It further states that "In case a post already exists in the scale of Rs.7450-11500, the post being upgraded from the scale of Rs.6500-10500 should be merged with the post in the scale of Rs.7450-11500."

Further, again in the order dated 13<sup>th</sup> November 2009, issued by Department of Expenditure, Ministry of Finance directed that, "The matter has been considered and it has now been decided that the posts which were in the pre-revised scale of Rs,6500-10500 as on 1.1.2006 and which were granted the normal replacement pay structure of Grade Pay of Rs.4200 in the pay band PB-2 will be granted Grade Pay of Rs,4600 in the pay band PB-2 corresponding to the pre-revised scale of Rs.7450-11500 w.e.f. Further, in terms of the aforementioned provisions of CCS(RP) Rules 2008, in case a post already existed in the revised scale of Rs.7450-11500, the posts being upgraded from the scale of Rs.6500-11500 should be merged with the post in the scale of Rs.7450-11500."

it may be noted that the cadre of Engineering Assistant (EA) in AIR&DD, carrying the pay scale Rs.6500-11500 and were granted the Grade Pay Rs.4200 and the cadre Senior Engineering Assistant (SEA) carrying pre-revised pay scale Rs,7450-11500 were granted the Grade Pay of Rs,4600 as per CCS(RP) Rules 2008.

While appreciating the implementation of Grade Pay Rs.4600 to Engineering Assistant as per the orders issued by the DG:AIR & DG:Doordarshan, we request your goodself to kindly take necessary steps to merge the cadres of EA & SEA as per the provisions of the same orders mentioned above which has been implemented partly..
