Sub: Request to forward the letters and details to PB Secretariat

Sir,

Kindly refer to our discussions with your goodself and thereafter with Sr.GM(P) on 30/11/2011 in which we requested you to kindly issue necessary instructions to the offices for starting the process, including deduction of subscription from the salary of the members, for recognition of Associations in AIR&DD. Later we met the Sr.GM(P), Prasar Bharati, since you were of the view point that Prasar Bharati is the nodal office for this process. Though we brought it to the notice of the Sr.GM(P) that we have already submitted all details required as per the CCS(RSA) Rules 1993, those details were not available in the Secretariat.

It may kindly be noted that your good office was kind enough to send the status report of 17 Associations with the details of 6 Associations (including ARTEE) with the remarks "**fresh Recognition under consideration**" to Ministry of I&B vide letter dated 12.10.1998. Later your office sent reminders in reference 3 to the Ministry for the same.


May I recall your goodself that we have once again submitted all details including the copy of constitution of Association, resolution for starting the check off system, list of office bearers and list of members of Association as on 12/9/2011 to your office vide the letter dated 12/9/2011. We have requested you to kindly **start the process of recognition immediately by starting the deduction of Rs.10/- per month or Rs.120/- per annum from the pay rolls of our members towards subscription of this Association.**

Meanwhile our members at various stations submitted their authorization for deduction of Rs.10/- (Rupees Ten only) per month from their salary towards the subscription of this Association. Thereafter, we have submitted the letter dated 14.11.2011 intimating that we (ARTEE) have a Savings Bank account in the Main Branch of State Bank of India, New Delhi, under the name "Association of Radio & Television Engineering Employees (ARTEE)" with A/c No.11084241652"

In the light of the discussions held with your goodself and the Sr.GM(P), I request you to kindly forward all letters along with documents to Manager (P) Prasar Bharati Secretariat as advised in their circular dated 22.11.2011.
