Sub: Request to Process for Recognition of Service Associations as per CCS (RSA) Rules 1993

Sir,

We request your kind attention to various letters from the recognized Associations through which it was brought to your kind notice that DOP&T, vide their letter dated 27/8/1998 informed Ministry of I&B and ARTEE that the order for the process of recognition issued by them is related to the service Associations of Central Secretariat only. They further informed that Ministry of I&B may take the initiative for the process for recognition of the Associations of employees under Ministry of I & B.

The Head of Department, DG:AIR was kind enough to agree in various meetings, that the status –quo should be maintained till the matter is processed by the Ministry of I&B. Accordingly your august office issued the orders in reference.No.4 & 6 to maintain the status – quo. It was stated that the matter will be taken up with the Ministry of I & B for processing the issue as per the RSA Act 1993. Your good office was kind enough to repeatedly take up the matter with Ministry of I & B for the last four years.

Later, the Ministry of I&B has intimated vide the letter No.B-12017/1/99-Admn. III (Vol. IV) dated 18.11.2009 that the matter of recognition of all service association including of Prasar Bharati under the new CCS (RSA) Rules, 1993 is under process.

We have pointed out to your office that, as per Section 8 of Central Civil Services (Recognition of Service Associations) Rules, 1993, the formalities for withdrawal of recognition is defined as: if, in the opinion of the government, a recognised Service Association has failed to comply with any of the set conditions, the Government may, after giving an opportunity to the Service Association to present its case, withdraw the recognition accorded to such Association.

Accordingly your good office has issued the letter No.B-12017/3/2010-WL, dated: 22nd February 2010 maintaining the status-quo of the recognition of the Associations which are in AIR manual, mentioning the modified names of the Associations as the names mentioned in the AIR manual are four decades back and the names are modified from time to time and the same has been reflected in the orders issuing from your office since long back.

Now since the process is lingering on for a long time, we request your goodself, being Head of Department, to start the process of recognition immediately by starting the deduction of Rs.10/- per month or Rs.120/- per annum from the pay rolls of our members towards subscription of this Association. List of members (a total of 9797) along with resolution adopted in the National Convention (meeting of the Central Committee), the copy of the constitution of ARTEE and the list of office bearers are attached for your kind reference. Request for immediate action in this regard to avoid further unrest in this organization.


