- [2]. If the answer of [15] 'NO' than under what authority DG Doordarshan has Mentioned the Employees who are Central Govt. Employees working in Prasar Bharati on deemed deputation as per decision of Hon'ble GOM and accepted by Ministry of I & B, Prasar Bharati and DG AIR as "Employees appointed as Prasar Bharati Employees" in Table II of the order issued above. Pl. provide copies of "Draft for Approval" and all papers of this file related to issuance of orders mentioned above..
- [3]. Pl. inform whether DG DD agree that some mistake is committed by its office.
- [4]. Pl. inform the names, designations of the all the officers involved in issuing these orders.
- [5]. Pl. inform the action taken by DG DD against the officers responsible for such mistake.
- [6]. Pl. inform the basis of issuing the order of granting Grade Pays on 04/11/2010
- [7]. Pl. inform who else can issue orders on upgradation of Grade Pays of staff apart from Cadre Controlling Authority.
- [8]. Pl. inform who among the DG All India Radio and DG Doordarshan is Cadre Control Authority as present.

- [16]. If answer of [4]. Is no pl. inform the reason.
- [17]. If answer of [2] and [4] are NO than who is the approving Authority to issue the order. (pl. provide me the copies of Draft for Approval and all file notings on this contentious issue.
- [18]. Pl. inform that whether DG Doordarshan in Anti Employee or averse of any benefit granted to Staff or Any order which is for Staff welfare.
- [19]. If not that pl. inform what is the reason of reverting it just eight days. Pl. also inform who is responsible for such blunder mistake.
- [20]. What Action DG Doordarshan is going to take against the officer who is responsible for playing with the sentiments of employees.
