

- (e) Copies of written declaration addressed to DDOs concerned, by members of the Association for deductions of subscriptions in favour of the Association (Annexure A & B and I) (copy enclosed)

They are requested to confirm the fulfillments of the conditions under Rule 5, 6 and 7 of the notification No. 2/10/80-JCA (Vol. IV) dated 5.9.1993 issued by DoP&T.
