We have brought it to your kind attention earlier also vide the letter in ref.No.2 above, that the issue raised by NFADE, is Repeal Prasar Bharati Act 1990 due to the experience for the last 13 years. The demand being a Policy decision, the Ministry of I&B only can take up the issue to Hon'ble Parliament of India.

This Federation will be obliged to have a formal meeting with your office on this issue only in case you assure that your high office is competent to take a final decision on the demand of NFADE, i.e., "Repeal Prasar Bharati Act 1990" and send the case directly to Hon'ble Parliament of India.
