Sir,


We've received a number of representations from our members stating that their applications for CGEWHO flat scheme - 2011 in Greater Noida are not being accepted by the CGEWHO office. It is being told to them that their applications are not being accepted as in their records AIR and DD figure as Autonomous bodies and the employees are thus non-government employees.

Sir, you may kindly appreciate that the Hon'ble GoM and the Cabinet have decided to retain the employees (joining upto 05-10-2007) of AIR and DD as Central Government employees, and accordingly all central government facilities are being extended to them.

But it is unfortunate that they are being deprived from the basic facility like housing by citing the ambiguity in the status.

It is therefore requested that a certificate clarifying the status and eligibility of the employees of AIR and DD may please be issued at the earliest. The last date for applying in the CGEWHO scheme is 3rd March, 2011.
