Sir,






We are grateful to your goodself for the initiative from your office, vide the letter referred above, to discuss the issue of NFADE.

We would like to bring to your kind attention that the issue raised by NFADE, i.e., Repeal Prasar Bharati Act 1990 due to the experience for the last 13 years, is a policy decision which can be taken by the Hon'ble Parliament of India. You may also agree that the initiative for the same can be taken by the Ministry of I&B not by your office especially when your office has already started the process of implementation of Prasar Bharati Act by initiating the formalities for recruitment rules, Board, etc. It is pertinent to note that, in our notice dated 09/08/2010, we have demanded to stop these process immediately till taking a final decision by the Hon'ble Parliament.

Under these circumstances, we feel that any negotiation in this regard can be taken with the Ministry of I&B only.

While expressing our due regards to your initiative we are advised by the Federation to intimate your goodself that we would discuss this particular issue only with Ministry of I&B instead of Prasar Bharati Management and it also decided to go ahead with the agitation programme as intimated in our notice.
