It is learnt that the meeting of the Hon'ble GoM held on 17/6/2010 decided to constitute two committees, comprising Secretaries/ joint secretaries of various ministries, to propose the necessary amendments in Prasar Bharati Act 1990 and also to propose on staff related matters.
