Respected Madam,


With regards this is to express our deepest anguish and resentment on the information that Ministry is going to implement Pay Parity to I.B.E.S. cadres while the decisions pertaining to welfare of Sub ordinate Engg. & Program cadres like

- [1]. Patna ACP (verdict is backed by Hon'ble Supreme Court) ,
- [2]. One Cadre One Pay (Verdict is backed by Hon'ble Supreme Court),
- [3]. Notional pay parity (fixation) with lighting Assistants (backed by verdict of Hon'ble High Court of Chennai),
- [4]. Merger of EA with SEA as per recommendations of 6th CPC and DOPT (backed by verdict of Hon'ble CAT Delhi) are being delayed on one pretext or the other.


There is strong resentment among the sub ordinate Engg. & Program cadres on such developments and if the pay parity to I.B.E.S. which is not on same footing as the issues mentioned above is granted in piecemeal manner by setting aside above pending issues then the SSS will be compelled to go on Nation wide Agitation. Details of which will be informed to your high office later. *In the light of above said facts SSS demands immediate stopping of grant of Pay parity to I.B.E.S. cadres of AIR & Doordarshan.*


An immediate attention is required as the matter is of utmost urgency.
