Subject: **View Point of SSS to the points raised in the letter submitted by Sh.P.N.Bhakta, Gen.Secy. AIR & DD Engineers Association(ADEA) dated 16/03/2011.**

Respected Madam,

Regards. Thing to your kind notice few facts about the above mentioned letter written to Hon'ble Secy. I & B by Sh. P.N.Bhakta, Gen.Secy. ADEA dated 16/03/2011 The letter is against the interests of Sub ordinate cadres and beyond the authority of Sh. Bhakta. This SSS condemns this letter in strongest terms and want to submit following few facts for kind consideration of your high office.

[1]. As you are aware that 6th CPC did not perform any cadre based study for Sub ordinate Cadres of AIR and Doordarshan and on our persuasion your high office was kind enough to carry out Cadre Review Exercise for us. It surprising to understand ADEA opposition for Cadre Review. Subordinate Cadres while it is being done to remove the age old anomalies.(ref para 2 of the above mentioned letter ,copy enclosed). The AIR & DD Engineers Association has been a party to the Cadre Review Committee earlier of which around 16 Meetings were conducted and with the consent of this Association a proposal of Cadre Review from Helper to E.in.C. was submitted to Prasar Bharati after the approval of DG All India Radio (Cadre Controlling Authority). Due to some recommendations of 6th CPC the proposal has to be modified. It is nothing but a change of stand with the ill intention of ADEA which represents so called highly qualified cadres. However it is a known fact that without sub ordinate/ operational Cadres any organization can not function. So we reiterate that Sub ordinate Cadres need Cadre Review Exercise without any further delay to solve the age old anomalies and our Cadre Review Exercise is not against any one. If the exercise of doing Cadre Review is done for organized Cadres is done it will further deteriorate the anomalies like Stagnation etc in sub ordinate Cadres. So in our view Cadre review of organized cadres can not be done without the cadre review of sub ordinate Cadres.

[2]. The stand of ADEA not allowing Diploma/ITI Holders to enter organized cadre without Degree in Engineering is condemnable and have not been considered tenable in PATNA ACP Case upheld by Hon'ble High Court of Patna and by Hon'ble Supreme Court. (Para 3 of the letter of Sh. P.N.Bhakta., copy enclosed)




[3]. SSS also condemn the beyond authority act of Gen.Secy. ADEA raising objection on granting scale of 8000-13500 as first upgradation and 10000-15600 as second under ACP scheme considering the scale of Engg.Asstt / SEA/ Asstt. Engr as 6500-10500 to the applicants as per the verdict of Hon'ble CAT Patna and upheld by Hon'ble High Court and by Supreme Court. The Wisdom shown in the letter is also questionable as the letter is questioning the verdict backed by the Apex court of the country. Surprisingly the letter indirectly question the sanctity of Govt. orders also as it objects the grant of scales through ACP.




