### PRESS RELEASE

- [1]. One Cadre One Pay : There are so many cadres with multiple scales while Designation, duties and responsibilities are same. The demand is backed by verdict of Hon'ble Supreme Court.
- [2]. ACP benefit as per verdict of CAT PATNA backed by Hon'ble Supreme Court.
- [3]. Grant of Pay Parity to Sr.Tech/Tech. with Lighting Assistants as per verdict of Hon'ble High Court Chennai.
- [4]. Merger of Engg. Asstts with Sr. Engg. Asstts. As per DOPT instructions.
- [5]. No withdrawal of 25<sup>th</sup> Feb 1999 agreement.
- [6]. Outsourcing of Man Power from BECIL, SHAFF etc.
- [7]. Cadre Review of Sub ordinate Engg. & Program Cadres.
- [8]. Security of AIR & DD Installations.

The First Phase Agitation : The SSS has served an Agitation Notice to Hon'ble Minister of I & B through letter no. SSS/06/04/2011 dated 19.04.2011 and as first Step, Gate Meetings were organized in Delhi, Mumbai, Kolkata, Chennai and Guwahati on 28<sup>th</sup> April 2011. In Delhi the Gate Meeting was conducted in Akashwani Bhawan.

As second step Members displayed Black Badges from 9<sup>th</sup> to 11<sup>th</sup> May. 2011 during duty hours and throughout the country with determination.

At the end of this step Gate Meetings were organized in Delhi (DG Doordarshan, Mandi House, Delhi), Mumbai, Chennai, Guwahati and State Capitals through out the country. Meeting was addressed by Sh. Umesh Chandra, President, ARTEE, Sh. Kulbhushan Bhatia, Gen.Secy., ADTEA, Sh. Sanjay Kumar , President PSA.

The Second Phase of Agitation.




Second Step : Relay Hunger Protest from 19<sup>th</sup> to 21<sup>st</sup> July 2011 throughout the country.
