**Subject : Regarding retention of staff quarter at old Station for the staff posted at K-B-K. District(Orissa) .**


Enclosed please find the request of Association of Radio & television Engineering Employees vide their letter No ARTEE/P/DG (AIR)/2010/08 dated 17.12. 2009 & 12.5.2010 on the above-mentioned subject.

2. ARTEE have requested the department to grant the permission to the employees of AIR & Doordarshan for retention of staff quarter at the old station when they are posted to any station in the districts of Kalahandi-Bolangir – Koraput(KBK)and Kandhamal, Boudh & Gajapati in Orissa(List as per annexure-A). It is stated that the Government of Orissa, General administration Deptt. Bhubaneswar vide their RESOLUTION No. 24003 & 24004 dated the 16<sup>th</sup> August 2001, declared that " If a Govt. servant is in occupation of a Govt. quarter prior to his transfer to any of the districts viz KBK Areas and in the Gagajpayti, Kandhamal and Boudh districts, he would be allowed to retain the same at normal rent, if he so wishes. Such retention would be allowed only on the grounds of Children's education/ and health of close family member. This facility will be available for a maximum period of three years or till the employee is in service in the above-mentioned districts, whichever is earlier. This facility will be available to all places in Orissa including Cuttack and Bhubaneswar".

3. In view of the above it is stated that the State Govt. has declared this facility but Central Govt. has not issued any orders regarding the above issue. Some of the stations of KBK (Koraput, Bhawanipatna & AIR Jeypore) have been declared difficult stations only for the purpose of tenure posting and not for retention of quarter by the Govt. employee who has been posted to KBK District(Orissa). It may also be stated that Central Govt. has allowed only the employees posted to J&K and North East to retain the quarter at the old place of posting for the bonafide use of their families. But till today Central Govt. has not issued any orders for the above said Districts.

4. Ministry of I&B is therefore requested to take up the matter with Ministry of Home Affairs to consider issuing of necessary orders to allow the employees to retain the quarter at old station while posted at KBK District (Orissa).
