**Subject: Grant of MACP to the employees of Prasar Bharati in General and also to employees of the 11 categories who have been granted upgraded higher scales in particular- req.**

The matter regarding grant of MACP to the employees of Prasar Bharati in General and also to employees of the 11 categories who have been granted upgraded higher scales in particular was considered in Prasar Bharati and the same was approved by the Prasar Bharati Board in its 109<sup>th</sup> Meeting held on 06.08.2012. A copy of the extract of the minutes is enclosed herewith as Annexure-I.

2. The matter has been further examined in consultation with the Finance Wing, Prasar Bharati and also in the light of the following facts:

- i. As per the Prasar Bharati (Broadcasting Corporation of India) Amendment Act, 2011 dated 9<sup>th</sup> January, 2012 Notified by M/o Law and Justice, "All officers and employees recruited during the period on or after the appointed day till the 5<sup>th</sup> day of October, 2007, shall be on deemed deputation to the Corporation with effect from the 1<sup>st</sup> day of April, 2000 or the date of their joining service in the Corporation, whichever is later and until their retirement".
- ii. The above Amendment Act, 2011 also provided that "The officers and employees referred to in sub-section (1) and (2) shall be entitled to the pay and all other benefits admissible to an employee of the Central Government".

3. From the above provisions of the Amendment Act, it is derived that all officials appointed in Prasar Bharati till 05.10.2007 are entitled to all the benefits enjoyed by Central Government employees, including the benefit of MACP. Accordingly, all the action of AIR/Doordarshan to grant MACP to all categories of employees appears valid and justified.

4. In view of the above, both the Directorates are requested to bring into the notice of all concerned of the above decision and initiate necessary action regarding fixation of pension and pensionary benefits so as to settle all pending references and grievance petitions.
