Merger : The dream comes through

The 5th central pay commission clearly pointed out in its report that the promotions in Central Government departments are practically very less now a days and they have recommended the ACP as an alternative to remove the frustration in employees due to lack of promotions. Most of the Corporations have already incorporated the idea of Time scales wherever promotions are not taking place in due course of time.

While interacting with the Review Committee under the chairmanship of E-in-C, AIR. Association floated the idea for the recruitment Rules for Prasar Bharati. It is a fact that the promotions are very slow in AIR & Doordarshan. We have demanded that provisions for time scale after every span of seven years should be available in Prasar Bharati if the regular promotion is not taking place within seven years.

In the changing scenario after the concept of ACP and Time scales the ideology has been changed from more number of cadres to less number of cadres to make time scale meaningful.

Accordingly we strongly demanded that all intermediate cadres in Engineering chain should be done away with in Prasar Bharati. We demanded merger of four cadres with their next cadres i.e. Khalasi with Helper, Senior Technician with Engineering Assistant, Senior Engineering Assistant with Assistant Engineer and Assistant Station Engineer with Station Engineer (in addition to the merger of Diesel Engine Driver with Technician and Diesel Technician & Mast Technician with Senior Technician which was already agreed by Prasar Bharati Board some time back). It is also a reality that the cadres of Sr. Technician and SEA were created by the department on the demand of this Association long time back which has created an opportunity for promotions to our cadres. We have demanded for opening of promotion channels in Prasar Bharati in line with the RRs prevailing in the CPWD and other engineering organisations.

The other constituents of JFADEE also agreed with our viewpoints and we have presented a common proposal in the RR committee meetings for better RR in Prasar Bharati.

ARTEE welcomes Sh.Priya Ranjan Dasmunshi on taking charge as Hon'ble Minister for Information & Broadcasting and Parliamentary Affairs.

Unfortunately the chairman of the committee has opposed this proposal. After our vigorous efforts in all the meetings of RR committee as well as with CEO and other officials E-in-C, AIR has recommended the merger of Khalasi with Helper and ASE (ADE) with SE(DD) and to open the promotional channel for Diploma/ Certificate holders, though a very small percentage. Again we pursued the matter with CEO, Prasar Bharati in which he has assured that merger of these cadres will be taken separately with Prasar Bharati Board as it was not recommended by the chairman of the committee.

We express our sincere gratitude to Sh.K.S.Sarma, CEO for his efforts for getting it approved in the Board meeting held on 17th November at Mumbai. The remaining points of the RR for Engineering cadre and the RR for other disciplines are yet to be discussed in the Board. The decision of the Board has to be approved by the nodal Ministries before notifying it.

If it is implemented it will be a historical achievement for the Engineering cadres of AIR & Doordarshan as a number of hurdles in the career prospects of our cadre members including Technician and EA will be removed.

For example: It requires 15 to 20 years for Technician and EA to get the promotions of Sr.Tech and Sr.EA respectively. Then one has to wait for a good number of years to get promoted as EA or AE. If the merger takes place they can jump one cadre automatically when the turn comes for promotion. With our demand of time scale, this will have revolutionary implication in our cadres as it will give substantial boost in pay compared to the present scenario. This effect will be applicable to all cadres from Khalasi to AE. Proposed changes in the cadre structure will have to be supported with necessary amendments in the AIR/DD manual.

The proposal from ARTEE included the demand for inclusion of senior most Technicians and EAs in the merger with upper cadres, which is ratified by the National Convention also. It is the wiseman's words that we should make a start while looking for more benefits. Our demands as in our proposal as included in next page is existing for further discussions.

The basic concept of our proposal in the changing conditions of virtually stagnated cadres is:

1. ***Make the channel open for the cadres without any bars and on the same time giving due weightage for qualifications***
2. ***Minimum number cadres in the promotion chain***
3. ***Regular Time Scales in compensation to delay in promotions***

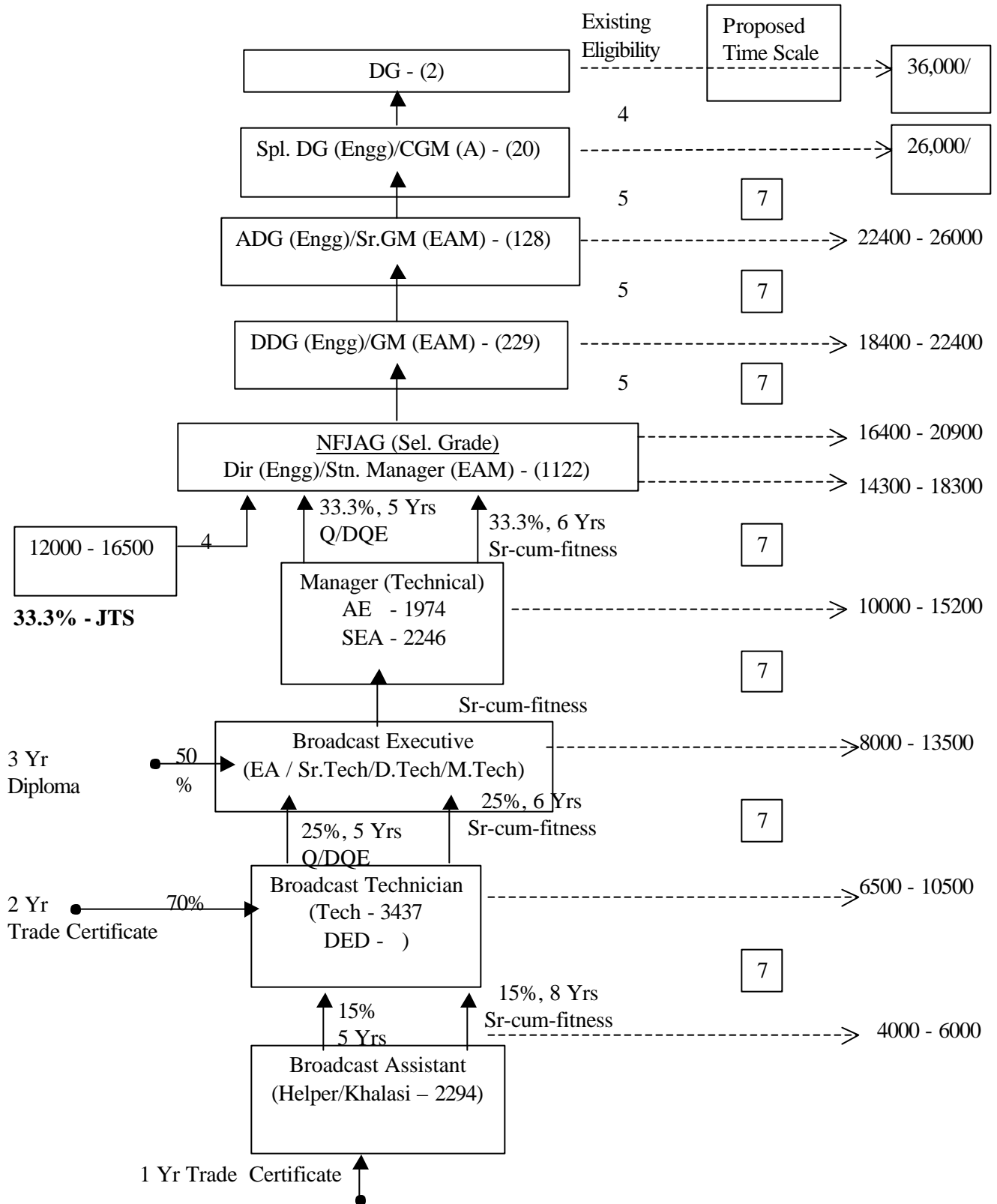
Essence of the proposal is that, in case there is no/ late promotion in the cadre, the incumbent will be financially compensated by time scale/s with a span of seven years as shown in the proposed structure.

For example;

If the proposed merger materializes and if one gets four/three time scales;	If the proposed merger does not materialise and if one gets four/three time scales;
After joining in the cadre, EA may reach the pay scale of CE/Sg E	After joining in the cadre, EA may reach the pay scale of SE/ASE
Technician may reach the pay scale of DE/DDE	Technician may reach the pay scale of AE/SEA
Helper may reach the pay scale of SE/AE	Helper may reach the pay scale of SEA/EA

This will be a historical achievement for our cadres if we succeed in our efforts. We have demanded for the change in designations in line with the identity of the work. We are fighting under the banner of JFADEE for Recruitment Rules in Prasar Bharati and other common issues related to Engineering cadres. For service conditions and other common issues related with all cadres of AIR & Doordarshan we are fighting under a united banner of NFADE.

News in Brief

NFADE met New Minister: NFADE delegation led by the Chairman Sh.R.Dasgupta had an introductory meeting with Sh.Priya Ranjan Dasmunshi on 23 Nov 2005. While appreciating the concerns of the Federation on the future of AIR & Doordashan, hon'ble Minister has informed that he has already been briefed by the Hon'ble Prime Minister on this issue. Hon'ble Minister stated that he is looking for the briefing from Ministry and Prasar Bharati officials to have a detail meeting with Federation. He has assured that NFADE will be called for that detailed meeting within one month and he will take the decisions on these issues only after consulting with NFADE.

Automation of LPTV/HPTV: ARTEE has taken up the matter of Automation with various authorities including CEO, Prasar Bharati and DG, Doordarshan. This issue was discussed in the meetings held with DG, Doordarshan on 26th April and with CEO on 21st September 2005. The report prepared by the Kerala State Committee and DDK Thiruvananthapuram unit was submitted to Sh. S. Jaipal Reddy, the then Hon'ble Minister for I &B, Member Personnel, Prasar Bharati, DG, Doordarshan and CE, Doordarshan at the dais of the National Convention at Chennai. When it became known that the authorities are going ahead with the plan of automation, already approved by the Planning Commission, all the three constituents of JFADEE decided to take up this matter with the authorities. After the letter issued by the JFADEE to the CEO on this issue, Sh. N. S. Ganesan, E-in-C, Doordarshan is going to call a meeting as per the directive of the CEO, Prasar Bharati. We are determined to put our

best efforts to stop the automation in LPTV/HPTV at the cost of employees.

New Definition of OTA rules at AIR Bathinda: The engineering staff of AIR Bathinda (Punjab) are facing a new phenomenon, the dealing assistant became habitual in simply deleting the OTA claims of the staff performed on declared holidays. In such an example the dealing assistant has deleted the OTA claim for the duties performed on the holidays of 14/4/2005 and 18/4/2005. It is interesting that the staff working at DDK Bathinda just opposite to AIR Bathinda have received the OTA for these days. As the HOO has not taken any action, the staff are advised by the Central office to submit formal application to the DG, AIR for necessary action.

Reclassification of cities/towns for HRA&CCA on the basis of 2001 Census: Ministry of Finance has issued orders for grand of revised rates of HRA and CCA as per the reclassification of cities on the basis of the 2001 Census. They have issued another order for the retention of existing classification to the cities which have been placed in lower classification. Association has approached both the directorates for the implementation of these orders.

Enhancement in Additional HRA for North East, Andaman & Nicobar and Lakshadweep Islands: Ministry of Finance has issued orders for grand of Additional HRA in enhanced rates on the basis of merger of Dearness pay with basic pay. Association has approached both the directorates for the implementation of these orders.

Court Case-Update

- **New EA Case:** Case came up for hearing on 27th August 2005 and now case has been admitted for arguments. The date of final hearing is awaited.
- **Pay-fixation of EAs prior to 1978:** This case was initially filed by Sh. R.K. Handa, Sh. J.M. Nangia and Sh. P.D. Sharma in Delhi CAT. But the case was taken up by the Association for monetary and administrative back up. Delhi CAT delivered a favourable verdict in 2002. Government did not implement the order. Subsequently the case was taken up at High Court and finally to Supreme Court. Matter was heard and was listed for final hearing on 09.09.2005. The Judges of the bench were on leave. Now it is listed for 06 January 2006.
- **Technician's Pay revision case:** In this case our MA (Miscellaneous Application) has been admitted in Delhi High Court on 10th January 2005. The case came up for hearing on 9th November 2005. Next date is 16th March 2006.
- **NFADE Case:** Hon'ble Supreme Court has admitted the case filed by NFADE, questioning the financial viability of Prasar Bharati. The Federation is also a party in the Supreme Court Case, filed by Prasar Bharati. In the hearing on 02nd August Hon'ble Supreme Court directed PB and Govt to finalise all the formalities for transferring the employees into Prasar Bharati within four weeks time. After the tremendous pressure from NFADE,

Govt has filed an affidavit seeking more time till settling the financial viability of Prasar Bharati. NFADE also filed an affidavit in the similar lines. In the hearing took place on 30th November 2005 the Hon'ble Supreme Court has granted 6 months time for the Govt to complete the formalities. When

our advocate pointed the delay due the Govt as they aware that Prasar Bharati is financially unviable, Govt advocate also admitted it and informed the Court on proposed Group of Ministers to find out some solution.

Meanwhile as per the order referred as No.2 above, it is stated that the cities/towns which have been placed in a lower classification in the lists annexed to the OM dated 18/11/2004, compared to their existing classification, shall continue to retain the existing classification until further orders and the Central Government employees working therein will be entitled to draw the rates of CCA and HRA accordingly.

Sub: Re-classification of cities / towns on the basis of 2001 Census -grant of House Rent Allowance (HRA) and Compensatory(City) Allowance (CCA) to Central Government Employees.

The undersigned is directed to refer to the Ministry's O.M. of even number dated 18.11.2004 on the above mentioned subject and to state that the cities/towns which have been placed in a lower classification in the lists annexed I and II to the said O.M., compared to their existing classification, shall continue to retain the existing classification until further orders and the Central Government employees working therein will be entitled to draw the rates of CCA and HRA accordingly.

2. These orders shall take effect from 1.4.2004.

3. All other conditions governing grant of HRA/CCA under existing order shall continue to apply.

4. In their application to employees serving in the Indian Audit and accounts department, these orders issue after consultation with the Comptroller and Auditor General of India.

Sub: Meeting on Automation

Sir,

It is learnt after various meetings with individual Associations that the Directorate of Doordarshan is moving ahead with a proposal for the replacement of existing LPTVs across the country with new transmitters(in pair). These transmitters will be operated by remote control. Also it is learnt that there is a move that these LPTVs will be ultimately unmanned either totally or partially in a bid to reduce staff though the data is still not available.

It appears we are heading for analogue transmission for another 20 years to come, when all the major developed and developing countries are already in the process of change over from analogue to digital. On the other hand the declared policy of the govt. is to go for digital transmission in a phased manner.

A question comes to anybody's mind that what is our National Policy on terrestrial T.V. transmission? Is it to go on with outdated analog systems at the cost of modern digital technology?

We feel that detailed discussions/debates with Associations on the advantages and disadvantages of the project in the prevailing socio-economic conditions of the country as well as the organisation is utmost necessary to maintain faith on the system and to maintain the conducive atmosphere in this august media organisation.

We request your good office to kindly grant an *urgent meeting*, to discuss exclusively on this issue.
