# **BETTER SENSE PREVAILS**

Dear Comrades,

The new CWC took charge on 7<sup>th</sup> March 2006 after the conclusion of election for the term 2006-2008. We are aware that the expectations of our members are very high after electing a young team to lead the largest Association of the employees of AIR&DD.

We are passing through a very crucial juncture as we have to ensure the existence of AIR&DD when our service itself is at stake and also to fight for the genuine demands of our cadres. Realising the seriousness of the situation we have decided to strengthen the struggle on the issues identified at the National Convention, immediately after taking charge of the new CWC.

But unfortunately some incidents were taking place internally. Some of the candidates were not ready to accept the verdict of the election. Even some of the elected office bearers who were not happy as the candidates of their liking did not win in key posts and started creating problems from the first day itself. Glaring outburst was that of Mr.Ram Shanker, Treasurer, who after taking charge of accounts and all assets of the Association on 7<sup>th</sup> March 06, demanded RO for a fresh election in writing, which was viewed very seriously by the enquiry committee also. Thereafter he refused to function as treasurer rather tried to veto the decisions of President, GS and even the Central Executive on various matters like releasing funds for Filament etc. He even declared in the Central Executive meeting that he will decide the contents of the Filament if he has to release the fund for it. In the era of fast communications, the news communicated immediately will be a news otherwise it becomes a stale story. We have made our efforts to publish the March issue of FILAMENT with the latest information of that time. But unfortunately the FILAMENT was kept piled up for dispatch for one and half months as Mr.Ram Shanker refused to release any fund from Association account. Ultimately the copies were dispatched to only major units with the contributions received from the members of AIR&DDK Delhi.

Meanwhile unsianed one circular dated 25/04/2006 has been issued by some persons through which they have tried to misguide the members by making false allegations against the previous body and the newly elected body and called for creating a new platform. In this circular they alleged that no statements of accounts were published for the last three years. The members were very well aware of the statements of accounts published in the October 2004 issue of FILAMENT and circulated and approved by the National Convention held at Chennai in October 2005. Members have not given any heed to that circular. Then these persons planned for other means to destabilize and destrov ARTEE.

When myself and Sh.Umesh Chandra (GS) returned from East Zone on 30<sup>th</sup> May 06 after a short tour, we were taken aback by the information that Mr..Bachchu Singh Meena, Mr.,Ram Shanker, Mr..Debashish Chowdhury and another person met both the E-in-Cs and CEs and declared that the elected body has been dissolved and they have taken charge of the Association. We have immediately clarified the officers that only the democratically elected body is leading ARTEE and no one else.

Even after all these activities we have shown utmost patience that these persons, who have availed privileges of being the office bearer of the Association for the last so many years, will realize the necessity of the unity of ARTEE and ultimately they will stop the destructive activities themselves in the wider interest of this Association which is catering to all its members like a mother.

But, it was shocking and appalling for any member to see that Mr.Bachchu Singh Meena issued a letter dated 01/06/06, using the letterhead of the Association, to the authorities declaring himself the President of ARTEE along with Mr.Debashis Choudhury as General secretary and Mr.Ram Shanker, Mr.Ram Prakash Sharma, Mr.R.K.Bajpai, Mr.Manoj Kumar Gupta, Mr.Hari Gopal Sharma, Mr.D.P.Singh, Mr.B.L.Meena and Mr.Bhagwan Dass as other officer bearers. Copy of the letter available in our website. It is interesting to note that S/s Ram Shanker, Manoj Kumar Gupta, Hari Gopal Sharma, D.P.Singh and Basant Lal Meena are elected office bearers.

ARTEE, being the leading Association to protect the welfare of subordinate engineering employees in particular and employees of AIR & DD in general in the light of the precarious condition of Prasar Bharati, has to be disciplined and united to fight against all the odds today.

This Association has been brought to the position of the largest and strongest one with tireless efforts of our senior leaders and members for the last 39 years. The Association, built from the sweat and blood of the thousands of members, can never be allowed to be hijacked, destroyed or defamed for the personal selfish interests of any individual or a group of persons. Accordingly Mr.Bachchu Singh Meena was placed under suspension from the primary membership of the Association on 02/06/06, after discussing with the Zonal Vice Presidents. The others, whose names were reflected in the letter issued by Mr.Meena has been asked to explain their position before 15/06/2006.

But instead of realizing the faults Mr.Bachchu Singh Meena kept issuing letters again in the letter head of Association to expel the undersigned along with Sh.R.Dasgupta, Negi, Sh.Umesh Chandra, Sh.Ramesh Sh.V.R.Hari (R.O) and Sh.Sudhir Navyar (ARO) from the Association. On the other hand the Bank account of the Association was frozen on the letter submitted the basis of by Mr.Ramshanker. Т had intimated these developments also to VPs and was waiting for the CWC meeting. Accordingly we uploaded the informations in the website also. Shockingly Mr.Ram Shanker called me up in my mobile phone in the night of 3<sup>rd</sup> June and threatened me on my life if I do not withdraw the information from the website immediately. I was compelled to lodge a complaint with the police to protect my life.

In the meantime we have received a letter from the O/o the Registrar of Society to clarify various points as per the affidavit submitted by Mr.J.M.Singh, Ex.VP(WZ) wherein he has demanded to cancel the registration of the Association. He has submitted the affidavit under the pledge that Association has failed to complete the formalities for the renewal of the registration from 1993 and made allegations of harassment of members by the Association by taking money for transfers in *collusion* with the authorities.(Authorities has now asked Mr.J.M.Singh to name the particular officers, Sh.Singh would have in mind in his affidavit). The affidavit was submitted after Mr.Anilkumar Gupta sought the information for this period under the Right To Information Act. The seriousness of the conspiracy brings to light of the fact that Mr.Ram Shanker was the Treasurer from 1993 to 2001 and GS from 2001-2003 and Mr.J.M.Singh was the Vice-President (WZ) in most of this period and Mr.Bachchu Singh Meena was President for 5 years from 1998-2003 and thereby it was the sole responsibility of these persons to send the audited accounts for that period and other documents to the Registrar to renew the registration in that period. Should it be concluded that this was a willful act of omission on the part of S/s Bachchu Singh, Ram Shanker etc so as to blackmail and hijack the Association in future if they fail to capture power by fair means of election as it was attempted now. It is important to note that outgoing CWC has already written repeatedly in last three years to Mr.Ram Shanker and Mr.Bachchu Singh to submit the audited report for the period from 1998 to 2003, but in vein. Without the audited accounts the formalities for the renewal of registration could not be undertaken.

Immediately after receiving the letter Sh.Dasgupta and Sh.Ramesh Negi rushed to Allahabad with available documents and got two months time to submit the relevant papers to the authorities. Here also Mr.Ram Shanker made efforts to block the documents stored in Almirah kept in the Room No.546 of Akashvani Bhavan by putting a new lock in the room all on a sudden. But some how we managed to open the room, with the help of an office bearer having the spare key, and took the vital documents to the Registrar.

As if it is not enough these persons started spreading the rumours that registration of ARTEE has been cancelled for ever.

Mr.Ram Shanker even challenged the authenticity of the CWC by declaring in the CWC meeting that ARTEE has been got de-registered! He even called the CWC as a gathering of a group of people! (see the height of disrespect for the Association).

The CWC was shocked to note that when no outsider is dare enough to question

the powers of ARTEE, our own people who has taken the shelter of the Association for years together has approached the Registrar to kill the Association to fullfil their ugly dream of a new Association as mentioned in their circular dated 25-04-2006.

The CWC discussed the matter in detail after hearing Mr. Ram Shanker also in detail and even offered to give chance to the defaulters back to the Association if they withdraw the unlawful actions in writing to the CWC for the wider interest. But instead of accepting their faults they have demanded for the apology from the President and GS for taking the actions. The CWC after the marathon discussions held for two days and nights decided to go for hard decisions to save the Association from further damage. Resolutions passed in the CWC are attached.

As decided in the CWC, I have already issued reminder letters by extending further one month time for submitting the reply for the explanation sought from those persons shown as Central Executives in the letter dated 01 June 2006 issued by Mr.Meena.

Now we are on job to defreeze the accounts as well as to complete all the formalities for submitting the relevant documents at the earliest to the Registrar of Societies. I am confident that we will clear all the formalities soon.

Let me clarify my dear comrades, No body can destroy our mother, ARTEE, when we are all together with respect and affection to that motherhood. Leaders will come and go but the Organisation should remain. No personal interest should come in the way of the Organisation which is meant for serving the wider interests of its members. Keep the flag of ARTEE flying high to save our service.

# <u>General Secretary's Report in CWC</u> <u>Meeting 18<sup>th</sup> & 19<sup>th</sup> June Delhi</u>

On behalf of Central Executive I welcome all members of Central Working Committee. This body took charge on 7<sup>th</sup> March 2006 after biennial election and started functioning immediately.

After customary introductory meetings with authorities. a letter in the form of charter of demands submitted Sh. Priyaranjan to Dasmunshi, Minister of Information & Broadcasting demanding immediate attention on burning issues like Outsourcing, Stagnation in AE cadre, mergers, filling up vacancies etc. A meeting is awaited, since the issues are very burning so the minister has instructed various departments to collect data and then a detailed meeting will be given to the Association.

In the meanwhile some of the contestants have submitted their request for recounting. To take decision about those requests President announced a three member committee under the chairmanship of Sh. M.K.Magazine (A.E., DDK Delhi). Other members were Sh. A.M.Sharma (A.E., AIR HPT Kingsway) & Sh. V.R.Hari (R.O.) This committee gave its report that recounting for the post where margin was less than 1% of total votes may be done. President decided 5<sup>th</sup> May 2006 the date for recounting. All the contestants were informed accordingly. On 4th May 2006 four members of Central Executive gave a letter not to do recounting. On 5<sup>th</sup> May this issue was discussed in length in the meeting of Central Executive, Contestants were also allowed to deliberate. After discussing issue in length Central Executive unanimously decided that in the larger interest of the Association not to do recounting for any post.

Since Association was busy in Election so to start communication a Filament was prepared consisting all the relevant information to update the members. The FILAMENT was waited for want of stamps but Treasurer refused to pay money-having objections on the contents. Since Treasurer is in possession of all Fixed deposits, Cheq. Books which were handed over to him in the very first meeting in which handing & Taking over took place., there was no way except sending FILAMENT by collecting money from members.

# Shifting of Pay & Accounts office:

A problem aroused in EZ Zone when their Pay & Account office for Doordarshan stations of Bihar & Jharkhand had to be shifted to LUCKNOW. When the East Zone committee and some units brought into the notice of the Central Office, we took action immediately and met Authorities. The shifting was stopped and the work of these was shifted to PAO office of AIR Kolkata.

# SEA to AE Examination:

SEA to AE examination was notified in last of APRIL and was scheduled for 16, 17 & 18 June 2006. Only 45 days were given for preparation. Since it was vacation time and Delhi is hottest in June, Association has received representations from the members to get it postponed at least for a month. Association took this point strongly and immediately got it decided by E.in.C. (AIR) and the examination was postponed for a month. The new dates are in July ' 2006

# Helper to Tech.promotions in NEZ:

Helper to Tech exam result for all four zones was declared while for North East Zone it was withheld due to using unfair means in the examination. Association took up this matter and result for this exam except for those who were found guilty, declared and helpers of North East Zone got the promotions.

# SSS Movement:

As per the directive of National Convention where it was decided to launch an agitation to pursue our long pending demands from the appropriate platform. Possibility was explored and talks began in JFADEE. Enggr's Association has it's reservation on the demand of Selection Grade and Opening promotional Channel for Dip A.E. They seek some time to decide. We have another platform of Sanvukta Sangharsh Samiti (SSS) of ARTEE & ADTEA. Immediately one charter of demand from this platform prepared and delivered to the Minister. An agitation program had to be chalked out, which couldn't be done & delayed due to recent Anti Association developments in the Association. After this CWC an agitation program will be chalked out and we will vigorously pursue our long pending issues of Outsourcing, Mergers, Stagnations etc.

# Workshop & Seminar at Kolkata:

On 23<sup>rd</sup> and 24<sup>th</sup> May'2006 DDK Kolkata unit arranged a workshop and seminar on the issue of 'Public Service Broadcasting – Its control, Administration and Financial Viability". President and General Secretary were invited to Kolkata, The DDK Kolkata Unit team including Abhijit & Shubhomoy under the leadership of Sh. P.K.Saha, Unit Secy. deserves a big applause for organizing the event very successfully. A lot of dignitaries from various arena of Arts and politics like Sh. Ajit Kr. Panja (Ex-Min. I & B), Sh. Hanan Mullah, M.P. and members Parliamentary Consultative committee for I & B, attended, Sh. Ashok Mukhopadhyaya (Journalist & Intelectual) and Ms. Rupa Ganguly (Noted Actress and Media personality), Chief Engrs. Sh. C. Rajagopal and Sh. G. Biswas, Sh. Jag Mohan Jain (D.E.) Of East Zone attended and opined in the workshop. Another part of workshop was based on "Health & Art of living".

### State Conventions of Jharkhand and Bihar:

After the Workshop, State office of Jharkhand & Bihar arranged a organizational tour of Ranchi & Patna. State Secretaries of Jharkhand and Bihar Sh. Chandra Bhushan Shukla and Sh. Uday Kumar Sinha deserve special appreciation that they arranged a State Convention of Both the States in such a short time. Sh. Babu Lal Marandi (Ex-Chief Minister) was the chief guest at Ranchi. Both the functions were very much successful and unit secretaries & DMC coordinators from entire Jharkhand & Bihar attended the function and deliberated on various important issues including stations' problems.

### **Court Cases update:**

As we all know a case backed by ARTEE to grant Rs. 6500/- scale to newly recruited Engg. Asstt.s was filed on the name of few EA's. The date of this case was on 29<sup>th</sup> May'06. The Govt. advocate was adopting delaying tactics by not appearing in court on one pretext or the other by taking dates after dates. On 29<sup>th</sup> our advocate protested and Justice gave date on next day. Next day again Govt. advocate didn't appear judged disallowed and finally on 31<sup>st</sup> May after arguments judge gave decision in our favor by instructing the Govt. to consider the scale of Rs.

To fulfill their own interests they are going even to the extent of damaging the unity, integrity and image of the Association. My appeal to all loyal members to strengthen this Association So that it can attain new heights. Elections will come and go, Individuals will come and go but the organization is our identity and should always be at first priority for all of us . Work for the Integrity and Unity of our beloved ARTEE.

Prokash Chakraborty (VP-AIR) explained current Anti Association Activities

Spreading biased and incorrect informations of financial bungling by circulating a false and fake Financial Statement on letterhead in which only income part is shown and not the expanses during last 2 1/2 years.

Submission of false Affidavit for cancellation of Registration of ARTEE by Sh. J.M Singh (Ex-VP-WZ) of AIR,HPT,Malad,Mumbai.

Illegal declaration by declaring himself self styled president by Sh. Bachchu Singh Meena.

Thereafter expulsion of President, General Secretary and other four members from ARTEE by self styled President.

The mention of four Central executives in the declaration by Sh. Meena also told to house. It is also informed that these office bearers were asked to clarify their position whether their names were included by Mr.Bachchu Singh Meena with their consent or not. But no one answered and letter sent to three of them Sh. Manoj Kr. Gupta, (ADD.G.S.), Sh. D.P.Singh (Secy-SEA/EA), Sh. Basant Lal Meena (Secy-S.Tech/Tech.) on the addresses given by them during filing nominations in elections were returned undelivered. These

Office bearers were asked to explain their position in the house.

Sh. Manoj Kr. Gupta (Add.G.S.) said that he is with ARTEE and will remain with ARTEE and even die with ARTEE. But he refused to comment on whether his name was given with his acceptance or not. But said Sh. Ram Shanker will speak on his behalf.

Sh. Harigopal Sharma (Secy.-AE) said the same thing.

Sh. D.P.Singh (Secy-SEA/EA) also gave same answer.

Sh. Basant Lel Meena (S.Tech/Tech) also given the same reply.

At this node Sh. Ram Shanker interrupted and asked time to deliberate. When he was allowed he started justifying his stand and blamed previous CWC and said the following :

Financial irregularity in respect of L.M. fee.

Expenditure w/o any discipline. Financial Bungling

to the Amount of Rs. 4 lakhs.

Has right to interfere in Filament's content.

Work of R.O. should not be appreciated, as he has not done any service to the Association.

Sh.R.Dasgupta's valedictory article should not have been published as this amounts to misuse of FILAMENT.

ARTEE's registration stands cancelled and present CWC is not valid as per the information provided by Registrar of Society, Allahabad to Sh. Anil Kumar Gupta, SEA, DDK Lucknow when he sough this information under right to information act. He also informed It is only a gathering of people and not a CWC.

Sh. J.M.Singh submitted an Affidavit to cancel the registration of ARTEE as it's fraud office bearers are illegally taking money in transfer, posting and appointments in collusion with authorities.

Since ARTEE is not registered any body can declare himself as president and can take over ARTEE.It is not illegal.

Mass irregularities and rigging in election by sending more ballots.


After the information of Treasurer there were chaos that why, how and under what intention Sh.A.K.Gupta (SEA) and Sh. J.M.Singh sought this information. House immediately demanded expulsion of Sh. J.M.Singh (Ex-VP-WZ) and Sh. A.K.Gupta SEA, DDK Lucknow. President clarified that After Sh.J.M.Singh filed an affidavit Registrar of Society sent a letter attaching copy of the affidavit and asked the Association to come in their office with all the documents upto 25<sup>th</sup> June. Sensing the urgency despite his ill health Sh. R.Dasgupta accompanied by Sh. Ramesh Negi rushed with whatever documents available to O/O R.O.S. Allahabad. All the documents submitted and O/O ROS assured that Name ARTEE cannot be given to anybody else. But all the documents from 1993 onwards are to be submitted with penalty fee within two months time and the registration will be renewed. President assured that we will complete all the formalities within stipulated time.

House resolved to expel Sh. J.M.Singh (EX-VP-WZ) and Sh. A.K.Gupta , SEA, DDK Lucknow unanimously from the primary membership of Association.

A resolution was moved from the presidium to expel Sh. Bachchu Singh Meena and Sh. Ram Shanker from the primary membership of ARTEE for their anti-Association activities.

All Zonal VPs opined on this issue and it was decided to form a committee of Zonal VPs to discuss with Sh. Meena to find a via media. This committee went to discuss the issue and came back late night and informed the house that Sh. Meena wants the contents of Appeal from President and General Secretary be withdrawn as this has hurt him very badly and unless it is removed there cannot be any talks.

House discussed the issue in details again. President and G.S. opined that why there is no mention of acts committed by Sh. Meena. After taking opinion of Zonal VPs, Zonal office bearers and all State secys. It was decided that committee of Zonal VPs will make one more effort to find out amicable solution the next day.



In the morning Zonal VPs discussed the issue with B.S.Meena in length and returned with the proposal from Sh. Meena that President and General Secretary should apologize to him for giving a appeal on the website and demanded that it should be removed immediately, the President and General Secretary should regret for that and after that he can think of coming back to main stream. Sh. Ram Shanker will allow to open the frozen account of ARTEE. While informing this proposal Sh. Raman pledged VPs solidarity with President and General Secretary.

House asked Sh. Rabin Dasgupta (Ex-President) to address and give his suggestions on this issue.

Sh. Rabin Dasgupta narrated incidents one by one and explained that this association is attacked from three corners. What President and GS done was a corrective measures to protect the Association. This CWC is called to discuss the crisis and either to pledge solidarity with President and General secretary or to condemn their actions and recommend disciplinary action against President and general Secretary. Otherwise the house should recommend disciplinary actions against those who took the Association for a ride.

After that General Secretary asked some time from the chairman and explained the sequence of events from the day when the new CWC took charge. The challenges faced , measures taken. He also described the unfortunate declaration by Sh. Bachchu Singh Meena and dubious roll of four central executives, their unavailability when crisis developed (all four of them were under ground) Scarcity of funds and non cooperation and seizing the Account by Treasurer. House also informed the how the CWC is being called with all sorts of hardships including funds. General Secretary also requested the house either to support their decision or to condemn us. If President and he did something to save the Association & some who performed Anti Association individuals Activities without regretting what they have done for coming back to main stream as corrective measure is not fair.

Sh. Manoj Gupta (Addl.G.S.) then gave his version of incidents and floated the proposal of regretting by President and General Secretary to Sh. Bachchu Singh Meena so that the incident is blown off.

At this juncture one member of Central Executive used abusive and un parliamentary language. On his remarks entire house got agitated and there was anarchy and chaos. During this Sh. Manoj Kr.Gupta (ADD.G.S.), Sh. Hari Gopal Sharma (Secy-AE), Sh. D.P.Singh (Secy-SEA/EA), Sh.Basant Lal Meena (Secy-S.Tech/Tech), Sh. V.S.Saxena (State Secy., MP), Sh. Arun Kr. Sinha J.S.(SEA/EA), NZ staged a walkout from the house.Most shockingly Mr.Manoj Kumar Gupta was seen dragging them out of the hall.

House expressed its anguish and unanimously passed following resolutions.

- 2. House resolves to remove Sh. Ram Shanker from the post of Treasurer and to expel from the primary membership of ARTEE.
- 3. A disciplinary committee under the chairmanship of Sh. J. Sengupta with all V.P's to tackle Anti Association Activities is formed.
- 4. House resolves to tackle emergency situation, President & General secretary were authorized to take corrective measures in consultation with all V.Ps.
- 5. House resolves to open a new A/c if there is any problem in operating the existing A/c.
- 6. Sh. Sunil Thapliyal V.P.(TV) is approved to do work of treasurer. As per constitution all Secretary(AE), Secy.(SEA/EA), Secy.(Tech./Sr.Tech.) who could be treasurer are already asked explanations for their position.
- 7. House resolves to take all steps to take all assets of Association back from Sh. Ram Shanker.
- 8. House resolves to expel Sh. J.M.Singh & Sh. Anil Kumar Gupta from primary membership of ARTEE.
- 9. House resolves to take all steps to complete all formalities with O/o registrar of Societies, Allahabad, regarding Registration & Recognition.
- 10. House resolves to give one month more time to other Executives of Central office to explain.

R.Dasgupta (Ex-President and Chairman) NFADE narrated the details of the meeting held with M.I.B. on 15<sup>th</sup> May and the internal information available regarding the G.O.M. held on 18<sup>th</sup> May 2006. He called upon the members to explore all the possibilities to meet the Ministers personally and to apprise them of the grave situation faced by AIR&DD vice-a-vis Prasar Bharati.

Agenda Point No. 8 On going Agitation by <u>SSS</u>: President and G.S. informed the house that the charter of demands prepared by SSS of ARTEE and ADTEA has been sent to Minister and very soon an agitation program will be finalized and announced. House unanimously empowered President and G.S. to go ahead with the agitation program.

Agenda Point No. 9 Court Cases Update :

General Secretary informed the house status of

court cases pending in various courts. As already told New EA case backed by ARTEE has already got a favorable judgment from CAT Delhi.

G.S. also informed that there is a demand to file a case for newly recruited Technician. All the possibilities are being viewed and after collection of data A case will be filed as quickly as possible.

AgendaPointNo.10ConstitutionalAmendments:It is felt that some constitutionalamendments are required to handle crisis andemergent situation like present scenario.HouseempoweredPresident to form a committee forConstitutional amendments which will be placedin National Convention for approval.

### Agenda Point No. 11 Any other matter:

### Extra ordinary stagnation in promotion of

**subordinate engineering cadres of East Zone:** Sh.Malay Kumar Das, VP(EZ) and Sh.Subrato Goswami, JS(EA/SEA-EZ) have raised the issue and urged the house to find some solution to ensure justice to the members of East Zone. It is observed that though Association has made all out efforts for solving the problem by making various proposals, the issue of stagnation still remains. After detailed discussion the house passed the following resolution: House resolved to explore all the possibilities for minimizing the extraordinary stagnation in the promotion of subordinate engineering cadres in East zone on priority basis, as it is a National issue.

### Separate Websites for zonal committees:

East Zone committee opined for separate websites for zonal committees as it is practically very difficult to incorporate all the information related to Zonal activities in the main website. Other zonal committees also supported the view point and house advised Sh.Ashwani Dagar, Website Administrator to explore the possibilities of obtaining sub-domains under the main site arteeindia.org for zonal committees. Zonal Vice President will be responsible for the materials uploaded in that sub domain. Sh. J. Anilkumar, State Secretary, Kerala proposed that State Secretaries should take the responsibility of furnishing staff position of the stations in particular state to the website administrator to minimize irregularities in transfers. It is also proposed to demand for lifting the ceiling of both OT hours and basic pay limit in the light of shortage of engineering staff. He demanded for reinstating of higher qualification incentives and cash award. He called for immediate starting of preparations for providing proper data to the next Central Pay Commission. It is demanded that the automation of LPT, takes place if any, should be restricted to remote localities only.

Charter of Demands submitted vide letter No SSS/05/2006, dated 09/5/2006 to the Hon'ble Minister.

Subject : Request for an urgent meeting regarding burning issues pertaining to the Engineering fraternity.

Ref. :Previous written requests and protests lodged by the individual Associations in respect of the various issues pertaining to the welfare of subordinate Engg. Employees.

Dear Sir,

It goes without saying that more than several requests for granting a meeting to the Engineering fora have resulted in nothing and though we are conscious that you are extremely busy with demanding tasks of the Government, your majesty being the head of our department, we have no other alternative but to approach your good office once again to kindly grant us an urgent meeting on the following long-pending issues. :-

[1]. Oursourcing of manpower in AIR & DDn : It has been given to understand that some high ranking officers of our organization due to their vested interest are trying hard to induct contract staff from BECIL and other sources in AIR and DDn. Furthermore, it is important to mention that work places of Akashvani & Doordarshan are highly sensitive areas carrying High Risk factors like RF & High Tension, Also sensitive from the point of view of national security. A Govt. employee is a person whose credentials are verified before induction into service, while a contracted person's credibility and loyalty cannot be ensured. Promoting contractorization at the cost of loyal and trustworthy regular AIR & DDn staff would be highly detrimental to the overall interests of our organization and the nation. We as a trio jointly oppose the outsourcing at all levels in Engg./Technical Cadres.

[2]. Merger of Sr.Tech with Engg.Asstt and SEA with AE : This matter has already been approved by Prasar Bharati Board after going through a massive and painstaking exercise, but it is still pending in Ministry for ratification.

[3]. Notional Fixation of Tech.& Sr.Tech. at par with Lighting Assistant : This matter also stands approved by P.B. Board but on account of one reason or the other, Ministry is dilly-dallying the matter and justice is being denied to the Technicians.

[4]. Financial & Carrier Stagnation in the Cadre of A.E.s. : It is evident that in A.E. cadre particularly A.E.s who are deprived of promotions since so many years are worst sufferers of financial and carrier stagnation. Situation is so worst that Stagnations are about to reach lower cadres like SEAs and EAs. Immediate grant of selection grade is only respite for financial stagnation. We strongly demand to grant the selection grade to AE cadre on the pattern of some other deptts. like Railways, Audit & Account Services, Central Secretriate Services etc. As explained earlier there is large scale carrier stagnation in A.E. cadre because of a derogatory qualification Bar for promotions to ASE. Acknowledging the importance of Higher Qualification we are not averse to giving advantage to AEs who have gained higher qualifications. But it is also harsh to deny AEs from any carrier progression, who are deprived of promotions for the last so many years. It is not out of context to mention that this Engg. staff contribute to more than 50% of total Engg. Employees and have no future. They are bound to face a total carrier blockage without any parallel example in any other department. It is demanded that the 33:33:33 formula which is already implemented in CPWD and other departments and already proposed in RRs framed for Prasar Bharati should be implemented without any further delay. It may pl. be noted that CEO-PB has already agreed for selection grade as short term and promotions on the basis of differential length of service as long terms measures to remove financial and carrier stagnation.

**[5]. Filling up of vacant sanctioned posts and resorting to recruitment holiday till then**: A considerable number of posts are lying vacant in almost all the cadres where direct recruitment is done. Serious and sincere efforts are required to be made to fill up vacant posts but till it is done, recruitment holiday clause may be pressed into service as a remedial measure, as has already been acceded to by

It is notworthy that recruitment Holiday is to be given to appr. 700 nos of posts of Technicians while posts lying vacant for Engg. Asstts. are 1400. Likewise, in the cadre of A.S.E. promotions, recruitment holiday may be resorted by distributing posts in 50 : 50 ratio between qualified and A.E.s who are deprived of promotions for the last so many years.

**[6].** Automation of LPTs : Our Associations are not against the upgradation and adaptation of latest technology but it should be logical and not at the cost of employees. A well defined policy should be finalized for LPTVs before switching over to Automation. It should be as per the staffing norms of the department. The Associations should be taken into confidence before that. Simultaneously it should not be just for the sake of purchasing dump, scrap and obsolete technological equipments.

[7]. Benefit under ACP Scheme for Engg. Cadres: ACP scheme is not being implemented in letter and spirit w.r.t. subordinate Engg. Cadres and needs to be applied uniformly to fulfil its real purpose in the interest of justice.

We are constraint to bring to your kind notice that these pending issues concerning Engineering staff have not attracted your kind attention, even when one of the constituent Association were on agitation in the recent past.

Now the situation is volatile and the Sanyukt Sangharsh Samiti(SSS) consisting of the two major Associations have joined for fulfilling the same demands. It is implored that an urgent meeting may kindly be granted to us so that the long pending genuine and justified demands may be fulfilled, failing which SSS will be constrained to resort to the path of democratic agitation as employees are already restive.

### Sub: Reorganisation of PAO(IRLA)

8 June 2006

The IRLA system of payment is peculiar to Ministry of Information & Broadcasting. The purpose for which it has been created was reviewed and it has been decided with the approval of Secretary, Ministry of Information & Broadcasting that PAO (IRLA) would be discontinued and its work be given to respective DDO/PAOs. The proposal has also been approved by the Controller General of Accounts, Ministry of Finance. 2. Under the new system, the following arrangements have been made:

- i) PAO(IRLA) will disburse salaries of all IRLA officers upto August 2006.
- ii) In order that the persons retiring in near future should not face any difficulty regarding finalisation of their pension, the IRLA officers of Prasar Bharati as well as non Prasar Bharati units retiring by February 2007 would continue to get their salary from the existing system of IRLA. Accordingly all IRLA officers retiring by 2007 will get their salary, GPF settlement, pension finalisation from PAO(IRLA).
- iii) For other officers of IRLA belonging to Prasar Bharati (i.e. officers retiring after February 2007), Prasar Bharati will have to make their own arrangement of disbursal of salary w.e.f.1.9.2006. PAO(IRLA) will arrange to send the necessary records to GM(B&A), Prasar Bharati as per the guidelines issued in this regard by Prasar Bharati.
- iv) After the payment of salary, GPF settlement and pension finalisation of IRLA officer retiring by February 2007, the PAO (IRLA) will wind up its operations and hand over the records to Grievance Cell by 31-3-2007. Grievance Cell will consist of 1 Sr.AO, 2 AAOs, 4 Accountants, 2 LDCs, 2 Group D & 1 Steno drawn from the staff of PAO (IRLA). Grievance Cell will work under Pr.AO, M/o I&B, The Grievance Cell look after all the grievances pertaining to erstwhile PAO (IRLA).
  - 3. For any clarification CCA, M/o Information & Broadcasting may be approached.

### 1. To rescind Prasar Bharati Act 1990;

The representatives of the Federation pleaded that Prasar Bharati Act, 1990 which was brought into force in November, 1997 may be repealed and status quo ante in respect of AIR and Doordarshan be restored. They were of the view that this was necessary as various facilities available to the employees of Prasar Bharati were withdrawn in a phased manner on account of their becoming the employees of the Corporation on deemed deputation to Prasar Bharati. Hon'ble Minister informed the representatives of the Federation that it was not possible to repeal Act at this stage but he assured that he would look into the matter to facilitate the restoration of withdrawn facilities.

### 2. To give full representation to employees as per the provision u/s 3(5) of P.B Act:

Hon'ble Minister informed the representatives that necessary action for election of two representatives on the Prasar Bharati Board would be taken once the services of the employees are transferred to Prasar Bharati

### 3. To fill-up vacant posts and Recruitment holiday in direct recruitment:

The Federation appealed that all the sanctioned vacant posts in Prasar Bharati should be filled up. They also wanted that recruitment holiday should be declared for the post falling in the direct recruitment category and which could not be filled up. The Hon'ble Minister informed that the necessary details of the vacant posts were being obtained and all efforts would be made in consultation with the Finance Ministry so that recruitment of all technical posts lying vacant could be filled up. This was also necessary so that all the news centres/offices of AIR and Doordarshan which were technically ready could be operationalised. He also assured to consider the proposals for recruitment holiday in the cadres where direct recruitment is presently not possible.

# 4. Ban on outsourcing in all cadres/works:

The Federation pointed out that number of jobs of Prasar Bharati were being carried out by outsourcing the same and such man power was being engaged against the sanctioned posts which were lying vacant. The Hon'ble Minister informed that he would look into the matter after obtaining the details from Prasar Bharati so that no outsourcing is done for the jobs which could be undertaken by existing employees

# 5. Implementation of decisions of Prasar Bharati Board which are pending in the Ministry:-

The Federation informed that a number of decisions taken by Prasar Bharati Board and recommended to the Ministry were not approved and implemented by the Govt. They wanted that all the Prasar Bharati Board decisions pending with the Ministry should be approved and implemented forthwith. The Hon'ble Minister informed that he would obtain the details of any such pending decisions and then taken necessary action.

### 6.To put the employees of AIR/DD within the terms & reference of VIth Pay Commission:-

The Federation apprehended that the employees of Prasar Bharati would be left out of consideration by the VIth Pay Commission on account of their being the employees of the autonomous body. They wanted that they should be kept within the ambit of the Pay Commission. The Hon'ble Minister informed that he will take up the matter with the concerned authorities, if necessary as and when the pay Commission is constituted because the employees continue to be central government employees only on deemed deputation to Prasar Bharati.

### 7. Grievances Redressal Mechanism:

The representatives of the Federation were not satisfied with the present grievance redressal mechanism in Prasar Bharati. The Hon'ble Minister assured that they need not apprehend anything adverse on this account and informed that both the *DGs* will be asked to attend to their grievances which can be solved at that level. He also assured that he himself will continue to take regular meetings with the employees and would also take up with GoM the major concerns of the employees The meeting ended with a vote of thanks to the Chair.
