Subject : **Agitation against Anti Employee functioning of Chief Engineer (NEZ) by not Implementing MACP.**

Respected Sir,

With regards this is to inform you about the Anti Employee function adapted by O/o Chief Engineer (NEZ) in implementing MACP in that Zone for EAs promoted after 01/01/2006 and helper cadre.

The MACP order is quite clear and the order by which Grade Pay of 4600 is granted to the employees carrying the pre revised scale of Rs. 7450 w.e.f. 01/01/06 is already implemented in our department. On the basis of this order the MACP for the staff in all four zones except North East has been implemented, ignoring EA to SEA promotions but CE(NEZ) is adamant in his Anti Employee Attitude by asking clarifications one after another for things which are already clear and implemented in other zones with the single purpose of delay it. On the same lines CE(NEZ) is asking clarification for some of Helpers also.

On this Associations persuasion DG AIR has instructed CE(NEZ) to implement MACP within 10 days but it is of no use. Undeterred CE(NEZ) has caused a widespread resentment among the staff Members if North East and they have been compelled to adapt the Agitational measures. So far the Agitation is peaceful but if immediate steps towards implementation of MACP are not taken by CE(NEZ) the staff may go on further Agitational steps which will jeopardize the functioning of the department and disturb the industrial peace.

Your high office is requested to immediately instruct CE(NEZ) to implement MACP. An early action in this regard is expected as the matter is very urgent.

Sir,

The undersigned, on behalf of ARTEE, NEZ, would like to take the privilege to convey the best wishes to you for taking the charge of DG:AIR, and hope you will give a patient hearing to the problems of welfare matters pertaining to North East Zone.

It is to bring to your kind notice that the members of ARTEE, NEZ are already on agitation from 30-03-2011, and as a part of the ongoing agitational programme, the Zonal Committee is observing Sit-in-Satyagraha in front of the chamber of CE (NEZ). A copy of the agitational programme, in demand of implementation of MACP to the cadres of Helpers and SEAs in North East Zone, was already intimated to your good office through our letter dated 14-03-2011 (copy is enclosed). Regarding the above mentioned demand, so many correspondence have been made for implementation of MACP to the cadres of SEAs joined after 01-01-2006, and issue of clarification regarding **fixation of Grade Pay** while implementing MACP to Helper cadres and promotion through DCE from Helper to Technician, but, as absolute silence was observed from the AIR Directorate end, this association was compelled to go for the course of its agitation in a democratic way. The next scheduled dates our agitation are on 07-04-2011 and from 08-04-2011 at 1000 hrs to till the demand is fulfilled.

It is therefore, requested your good self to take up the matter on urgent basis to remove the disparity in granting of MACP benefit to all SEAs irrespective of cutoff date and to the Helpers who are the most deprived cadre in granting of MACP benefit, and for that the clarification sought by CE (NEZ) should be sent immediately from your end for smooth functioning of this media units in North East Zone.


The undersigned, on behalf of members of ARTEE, NEZ, would like to invite your attention to the disparity shown by concerned authority towards extending the benefit of MACP to the SEAs joined after 01-01-2006, **which has already been implemented in other zones**; and disparity in granting of Grade Pay to Helpers while implementing the MACP, for which, under mounting pressure of this association, seven clarifications were sought from DG; AIR by CE (NEZ) Vide Ref. no.1 & 2, and subsequent letter submitted by General Secretary of ARTEE vide Ref. No. 2 to the concerned authority in Delhi for taking urgent action.

In spite of repeated requests, verbally and in written, the authority failed to grant the benefit of MACP to **SEAs joined after 01-01-2006** in North East Zone and review for correction of the fixation of Grade Pay in r/o Sh. Swapan Deb, **promoted to technician through DCE** and joined on 4th February, 2010 at AIR, Kailashahar and issue of clarification regarding grant of Grade Pay in MACP for Helpers in North East Zone. It is worthwhile to mention here that Sri Golap Das, Helper, DDK Guwahati is drawing less Grade pay to his junior working under DDMC Guwahati.

As the members are extremely agitated over the non-implementation of above mentioned issues on the pretext of clarification sought, and absolute silence from the Directorate end, this association has no option but to go for agitational programme as furnished below.

1. 30-03-2011 - Gate meeting during lunch hour at all the major stations in NEZ.
2. 31-03-2011 - Black Badge wearing at all the major stations in NEZ.
3. 01-04-2011 - Sit-in-Satyagraha in front of the chamber of CE (NEZ).
4. 07-04-2011 - Dharna during lunch hour in front of entrance of Administrative Office Building at all the major stations in NEZ.
5. 08-04-2011 - Sit-in-Satyagraha in front of the chamber of CE(NEZ) till the demands are fulfilled.
